**RE: NOTICE OF LIMITED REVISION  
OF PORT TARIFF – MARCH 1, 2021**

We refer to our letter with reference number DG/HQ/C.3/V.12/483 dated July 29, 2020 announcing the implementation of limited upward revision of Port Tariffs effective October 1, 2020. We also refer to the subsequent letter number DG/HQ/C.3V.13/569, of September 30, 2020 which was circulated to the Port Community suspending the implementation of the limited upward revision until further notice.

We wish to hereby give notice to the Port Community that the implementation of the limited upward revision of Port Tariff shall now take effect from **March 1, 2021**.

For the avoidance of doubt, the revision shall apply to containerised cargoes (Import/Export/Transit) only, as follows:

No	DESCRIPTION	USS	REMARKS
1.0	Port Dues on Cargo	10.00	Per TEU
2.0	Stevedoring Charges	15.00	Per TEU
3.0	Craneage	5.00	Per TEU
4.0	Terminal Handling- Empty Container	5.00	Per TEU

In order to streamline the administration of the Port Tariffs and to avoid dual tariff regime between the Port of Tema and the Port of Takoradi, the revised rates shall be applied to both Ports. It shall also apply to container operations at Terminal 1 and 2 in the Port of Tema.

We wish to further inform you that some tariff items have been restructured. We have also provided additional definitions and expanded some terms and conditions, in order to facilitate easy interpretation and application of the tariff.


We have attached the details of the revision and changes for your information and guidance.
